

# **LUMINARY AWARD RECOGNISING LEADERSHIP AND CONTRIBUTION**

## **OBJECTIVES OF THE AWARD**

To recognise an Engineering New Zealand Auckland Branch Member, of any grade, who has attained eminence amongst their peers as a leader and an inspiration to others, as a result of their selfless contribution to the promotion of Engineering New Zealand and the engineering profession, in the Auckland region.

This as an annual award to recognise a single member's contribution to the region in the previous calendar year, with the inaugural presentation taking place at the Auckland Branch awards evening on 26 May 2022.

## **CATEGORY**

- Luminary Award

## **CRITERIA**

The Engineering New Zealand Auckland LUMINARY AWARD, a nominee will be recognised by their peers as a leader in relation to the following award criteria:

1. The nominee has actively and positively promoted Engineering New Zealand and the engineering profession within the Auckland Region, to members of the public and amongst their peers.
2. The nominee has made a distinguished contribution to the development and growth of Engineering New Zealand within the Auckland Region in the previous calendar year.
3. The nominee is seen to embody the principles of the Engineering New Zealand Code of Ethics in their workplace.

# ELIGIBILITY

Nominees must meet the following:

1. Be a current member of Engineering New Zealand, at any level of membership. There is no minimum period of membership or service to Engineering New Zealand required.
2. Reside in the Auckland Region
3. Be nominated by at least two of their peers (Engineering New Zealand Members in the Auckland region)
4. Not have previously received the ENGINEERING NEW ZEALAND AUCKLAND LUMINARY AWARD.

# ENTRIES

Entries for the Luminary Award.

- c) Entries shall close at 5pm on Tuesday 5th April 2022
- d) Judging shall be completed at a date approved by the Auckland Branch Committee.
- e) The awards will be presented at the Annual Awards Dinner, which will be held on Thursday 26 May 2022

Nominations must be made on the Application Form and include the following:

- Nominator's names, and Engineering New Zealand membership numbers
- Nominee's name, Engineering New Zealand membership number and membership status (if known)
- A citation from the nominee (maximum of five hundred (500) words) outlining how you have achieved the award criteria.
- A citation from each nominator (maximum of two hundred (200) words) outlining the nominee's contribution to the Branch, including specific events and/or contributions in relation to the award criteria.
- Nominee's agreement to be nominated, by signature on the form
