

ENGINEERING NEW ZEALAND RULES REVIEW CONSULTATION



BACKGROUND

Over the past year we've been carrying out a review of our Rules. Some of our current Rules are overly complex, unclear or even inconsistent, particularly for our Branches and Groups, and make our volunteers' jobs harder than they need to be. Other rules are simply not followed as they no longer reflect the way we work. Our vision is to have Rules that are modern, streamlined and supportive of the way our Branches, Groups and members do business.

In consultation with members, we've revised our Rules to better reflect the modern and relevant organisation that we are, and how we do business. We want our Rules to support our operations and our volunteers rather than hinder them. We'll be asking our members to vote on these revised Rules at our AGM on 29 March 2019. In this paper we compare the final draft of the new Rules against the version we consulted with members on in October and November 2018, so it is easy for members to see what changed between these versions and why.

CONSULTATION

We undertook three rounds of consultation in 2018. The third round of consultation in October-November 2018 asked members to comment on a revised set of Rules. The Engineering New Zealand Governing Board considered the feedback from members as well as feedback from Engineering New Zealand's external lawyers. This resulted in some minor changes to the final draft which the Board approved for members to vote on at the 29 March 2019 AGM.

Many of these changes are stylistic, or simply add clarity to what was already in the working draft. Some additions have been made, for example to clarify procedures if certain circumstances arise around filling casual vacancies on the Board. A couple of sub-Rules have been removed where they have been deemed unnecessary.

Below, you'll find a copy of the Rules as they were put forward in the third round of consultation last year, alongside the final draft which was approved by the Board in February 2019. You'll also find brief notes about the changes to each Rule (if any) and the reasons why they were made.

RULE 8: CEASING TO BE A MEMBER

8.1 Resignation

- 8.1.1 Engineering New Zealand members may request to resign their membership by giving written notice to the Chief Executive.
- 8.1.2 The Chief Executive may refuse to accept a member's resignation if the Chief Executive believes, on reasonable grounds, that the Engineering New Zealand member is, or may soon be, subject to a complaint made under Rule 11. In this case, the request for resignation will not be actioned until the complaint process has completed.

8.2 Suspension and removal

- 8.2.1 The Board may, at its discretion, suspend or remove a member for the following reasons:
 - 8.2.1.1 If Engineering New Zealand loses and is unable to re-establish contact with that member for a period longer than three months;
 - 8.2.1.2 If the member's applicable fees or subscriptions are in arrears (and in accordance with the procedures set out in Rule 9.4);
 - 8.2.1.3 If the member has not complied with their obligations under Rules 4.2 and/or 4.3; or

RULE 8: CEASING TO BE A MEMBER

RESIGNATION

- 8.1 Engineering New Zealand members may request to resign their membership by giving written notice to the Chief Executive.
- 8.2 The Chief Executive may refuse to accept a member's resignation if the Chief Executive believes, on reasonable grounds, that the Engineering New Zealand member is, or may soon be, subject to a concern or complaint made under Rule 11. In this case, the request for resignation will not be actioned until the concern or complaint process has completed and the parties have been notified as such.

SUSPENSION AND REMOVAL

- 8.3 The Board may, at its discretion, suspend or remove a member for the following reasons:
 - a. If Engineering New Zealand loses and is unable to re-establish contact with that member for a period longer than 90 days;
 - b. If the member's fees or subscriptions are in arrears (and in accordance with the procedures set out in Rule 9.9 to 9.11);
 - c. If the member has not complied with their obligations under Rules 4.4 and/or 4.6; or
 - d. Pending the outcome of court or tribunal proceedings that may reflect on the member's fitness to be an Engineering New Zealand member.
